2013 has been plagued by natural calamities. The incessant monsoons and coastal typhoons have played havoc in Odisha, South Bengal and Bihar. Growth of Tourism in the year 2013

Foreign Tourist Arrivals (FTAs): Despite negative signals from the global economy, the number of foreign tourist arrivals in the country in 2013 showed an increase of about 4.1% over 2012. During the period January-December 2013, 68.48 lakh (Provisional) tourists visited India against 65.78 lakh in 2012.

Foreign Exchange Earnings (FEEs) from Tourism: Foreign exchange earnings from tourism in rupee terms during 2013 were Rs.1,05,836 crore (Provisional) with a growth of 12.0% over the same period in 2012. The foreign exchange earnings during 2012 was to the tune of Rs.94,487 crore.

STATUTORY ADVISORY

Subject: Extending time line upto 4th February, 2014 for the Food business Operators to obtain license / registration under the Food Safety and Standards (Licensing and Registration of Food business) Regulations, 2011.

In continuation of the statutory advisory dated 25.7.2012 issued by this Authority, it has been decided to extend the timeline to 4th February, 2014 for FBOs seeking conversion/renewal of their existing licenses and also for FBOs who have not obtained licenses/registration under the new Act.
